**6 ACCIDENTAL RELEASE MEASURES (STEPS FOR SPILLS)**

**6.1 Personal Precautions, Protective Equipment and Emergency Procedures:**

- Place in leak-proof containers. Seal tightly for proper disposal.
- Dispose of in accordance with U.S. Federal, State, and local hazardous waste disposal regulations and those of Canada and its Provinces, those of Australia, Japan and EU Member States (see Section 13, Disposal Considerations).
