








**5.3 Special Fire-Fighting Procedures:**

- Incipient fire responders should wear eye protection.
- Structural firefighters must wear Self-Contained Breathing Apparatus (SCBA) and full protective equipment.
- Isolate materials not yet involved in the fire and protect personnel. Move containers from fire area if this can be done without risk; otherwise, cool with carefully applied water spray.
- If possible, prevent run-off water from entering storm drains, bodies of water, or other environmentally sensitive areas.
